The 2020 Annual Winter Training/Awareness Meeting of the Northeastern Forest Fire Protection Compact will be a joint meeting with the Northeastern Forest Pest Council. The theme is a collaboration between forest health and fire management and is titled "Forest Pests and Fire". This session will be held at the Holiday Inn By The Bay in Portland, ME on January 28-30, 2020. The meeting will be two full days preceded by NFFPC Working Team meetings on Tuesday Jan 28th.
